V. How Do We Collect Your Data?

Eye Bank website has an E-Pledge page where potential Eye Donors may apply.

Step by Step procedure:

Step 1: A potential Donor filled in his/her data on the E-Pledge Form. Then clicked submit.

In this moment, his/her data is stored in a temporary secured storage until his/her application is validated and verified.

Step 2: Potential Donor will receive an email in the email account he/she registered containing the code needed for application validation.

Conditional next steps:

(Condition 1) Step 3: If potential donor filled in "Check-out my Donor Card" with the correct application code, he/she will receive his/her Donor Card via email and his/her record will be saved in Eye Bank's data center.

(Condition 2) Step 3: If potential donor was unable to "Check-out" his/her card within 12 hours after application, his/her information will be removed from the Eye Bank's data center.

VI. How Do We Keep Your Data?

All Donor information will be kept and managed securely by a specific level of administration from Eye Bank Foundation. No other entity will be able to manipulate all data incurred.
